## Hearing


The hearing for the property at 2946 Sahara Ave NE, Canton, Ohio was called to order by Dr. Stephen Hickman at 11:37 AM.




The hearing for the property at 505 Shorb Ave NW, Canton, Ohio was called to order by Dr. Stephen Hickman at 11:43 AM.


