13	Laboratory Director: As needed for succession planning and training purposes, allow position of Laboratory Director to be filled by 2 employees simultaneously, for no more than 2 consecutive months at any one time, only after written notice the Laboratory Director position will be vacated is submitted. Upon hire of the second person in the Laboratory Director position, the position will return to being filled by only one person by no later than 2 consecutive months thereafter, by one of the two people vacating the position on or before that date.
